Any person on conviction by the provisions of [this] ordinance may, at the discretion of the police justice, be committed to the work-house of the city of Hastings, and to be kept at hard labor until discharged by due course of law, as provided in ordinance No. 81 entitled an ordinance relating to the work-house of the city of Hastings.

SEC. 6. All ordinances and parts of ordinances conflicting with this ordinance are hereby repealed.

Sec. 7. This ordinance shall take effect and be in force from and after its publication in the official paper of the city. Passed January 6, 1868.

ORDINANCE NO. 74 (as amended by Nos. 91 and 83.)

AN ORDINANCE RELATING TO BREACHES OF THE PEACE, DISORDERLY CONDUCT AND THE CARRYING OF CONCEALED WEAPONS.

#### The Council of the City of Hastings do ordain:

SECTION 1. Any person who may be found lurking, lying in wait or concealed in any house or other building, or in any yard or other place within the limits of the city of Hastings, with intent to do any mischief or to pilfer or to commit any crime or misdemeanor whatever, shall for every such offense, on conviction thereof before the police justice of said city, be punished by a fine not exceeding one hundred dollars, and imprisonment in the city jail for a period not exceeding three months, or either, at the discretion of the justice, and moreover be held to bail for good behavior.

SEC. 2. Any person who shall make or countenance or assist in making any noises, riot or disturbance, or who shall be guilty of any disorderly, indecent, immoral or insulting

conduct, language or behavior, or who shall be in a state of intoxication in the streets or elsewhere in said city, and all persons who shall collect in bodies or crowds in said city for unlawful purposes, to the annoyance or disturbance of the citizens or travelers, shall for each offense, on conviction before said justice, be punished by a fine not exceeding one hundred dollars, or imprisonment in the city jail not exceeding sixty days.

SEC. 3. Any person who shall go armed within the incorporated limits of said city of Hastings with a dirk, dagger, sword, pistol or pistols, or shall carry a slung-shot or metal knuckles or other offensive or dangerous weapon, without reasonable cause to fear an assault or other injury to his person or to his family or property, shall, upon conviction before said justice, be punished by a fine not exceeding one hundred dollars, or by imprisonment not exceeding three months, or both, in the discretion of the justice.

SEC. 4. Any person on conviction by the provisions of [this] ordinance may, at the discretion of the police justice, be committed to the work-house of the city of Hastings, and to be kept at hard labor until discharged by due course of law, as provided in ordinance No. 81, entitled an ordinance relating to the work-house of the city of Hastings.

SEC. 5. This ordinance shall take effect and be in force on and after its publication in the official paper of the city.

ORDINANCE NO. 81 (as amended by No. 91.) AN ORDINANCE RELATING TO THE WORK-HOUSE OF THE CITY OF HASTINGS.

The Council of the City of Hastings do ordain:

Section 1. The city jail of the city of Hastings is hereby declared to be the work-house of the city of Hastings..

SEC. 2. The chief-of-police is hereby designated the manager of the work-house of the city of Hastings, and his duties shall be: First-to exercise a general supervision over said work-house and the management thereof. Second-to pre-
