Disturbing public peace.

Section 74. Any person or persons disturbing the good order and peace of said City by clamor or noise, by intoxication, drunkenness, fighting, using obscene or profane language, or shall otherwise disturb the public peace by indecent or disorderly conduct, or shall commit any nuisance, or be guilty of any lewd or lascivious behavior, or shall in any way disturb the public peace, or shall be found within the city limits loitering about saloons, dram shops or houses of illfame, or wandering about the streets either by day or by Begging, etc. night, or begging from residents or from any other person within said City and not having any known place of residence or any visible means of support, or not being able to give a satisfactory account of himself or themselves, or shall be a known prostitute, pick-pocket, burglar, thief, watch-stuffer, tramp or gambler, or shall practice any trick or game with intent to swindle, or shall abuse his, her or their family or any of them in any manner; each and every person so offending shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in any sum not exceeding fifty dollars, or be imprisoned at hard labor not exceeding thirty days, or both. Selling adulterated provisions. Section 125. That whoever sells any kind of diseased, corrupted, adulterated or unwholesome provisions, either animal or vegetable, whether for meat or for drink, without making the condition of the same known to the buyer, and whoever kills for the purpose of sale any calf less than four weeks old, or sells or has in his possession, with intent to sell, the meat of any calf which he knows to have been killed when less than four weeks old, shall be fined not more than fifty dollars, or imprisonment not more than twenty days, or both. Penalty.

Congregating on sidewalk.

Section 126. That it shall be unlawful for persons to congregate upon or occupy the sidewalks of the City, or to congregate at the corners of any of the streets of the City, or to congregate in such a manner as to occupy the sidewalks in front of any dwelling or place of business, or in front of any place of worship or amusement in the City; provided, that such persons have no occupation or business at such places. [March 17, 1880.

Duty of Police.

Section 127. That it shall be and is hereby made the duty of the police of the City to prevent such gatherings or occupations of sidewalks and street corners, and to arrest persons found violating the provisions of this chapter. [March 17, 1880.

Penalty.

Section 128. Any person found violating the provisions of section 126 of this chapter, shall on conviction thereof before the Mayor, be fined for the first offense not less than one nor more than five dollars, and for each subsequent offense may be fined in any sum not less than five nor more than twenty dollars. [March 17, 1880.

Carrying concealed weapons.

Section 129. That whoever carries any pistol, bowie knife, dirk, or other dangerous weapon, concealed on or about his person, shall be fined not more than two hundred dollars, or imprisoned not more than thirty days, and for a second offense, fined not more than five hundred dollars, or imprisoned not more than three months, or both. [March 17, 1880.

Section 130. That upon the trial of a complaint for Proviso. carrying a concealed weapon, the jury or the Mayor, as the case may be, shall acquit or discharge the defendant if it be made to appear that he was at that time engaged in a lawful business, calling or employment, and that the circumstances in which he was placed were such as to justify a prudent man in carrying the weapon for the defense of his person, property or family. [March 17, 1880.
